This Statement of Privacy applies to the Katy Car Insurance site and governs data collection and usage. By using the Katy Car Insurance site, you consent to the data practices described in this statement.

COLLECTION OF YOUR PERSONAL INFORMATION

Katy Car Insurance collects personally identifiable information, such as your email address, name, home or work address or telephone number. Katy Car Insurance also collects anonymous Katy Car Insurance graphic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests and favorites.

There is also information about your computer hardware and software that is automatically collected by Katy Car Insurance. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used by Katy Car Insurance for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Katy Car Insurance site.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Katy Car Insurance public message boards, this information may be collected and used by others.

USE OF YOUR PERSONAL INFORMATION

Katy Car Insurance collects and uses your personal information to operate the Katy Car Insurance website and deliver the services you have requested. Katy Car Insurance also uses your personally identifiable information to inform you of other products or services available from Katy Car Insurance and its affiliates. Katy Car Insurance may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Katy Car Insurance does not sell, rent or lease its customer lists to third parties. Katy Car Insurance may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. In addition, Katy Car Insurance may share data with trusted partners to help us perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Katy Car Insurance, and they are required to maintain the confidentiality of your information.

Katy Car Insurance does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

Katy Car Insurance keeps track of the Web sites and pages our customers visit within Katy Car Insurance, in order to determine what Katy Car Insurance services are the most popular. This data is used to deliver customized content and advertising within Katy Car Insurance to customers

whose behavior indicates that they are interested in a particular subject area.

Katy Car Insurance website will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Katy Car Insurance or the site; (b) protect and defend the rights or property of Katy Car Insurance; and, (c) act under exigent circumstances to protect the personal safety of users of Katy Car Insurance, or the public.

USE OF COOKIES

The Katy Car Insurance Web site use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Katy Car Insurance pages, or register with Katy Car Insurance site or services, a cookie helps Katy Car Insurance to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. When you return to the same Katy Car Insurance Web site, the information you previously provided can be retrieved, so you can easily use the Katy Car Insurance features that you customized.

You have the ability to accept or decline cookies. Most Web browsers automatically accept cookies, but you can usually modify your browser setting to decline cookies if you prefer. If you choose to decline cookies, you

SECURITY OF YOUR PERSONAL INFORMATION

Katy Car Insurance secures your personal information from unauthorized access, use or disclosure. Katy Car Insurance secures the personally identifiable information you provide on computer servers in a controlled, secure environment, protected from unauthorized access, use or disclosure. When personal information (such as a credit card number) is transmitted to other Web sites, it is protected through the use of encryption, such as the Secure Socket Layer (SSL) protocol.
